- 1. Your offer should be valid for a period of **120 days** from the date of opening of tender.
- 2. Please note that your tender will not be considered unless it is received in sealed envelope super scribed with tender number and due date. It should be put in the Tender Box kept at the Reception of Institute Building, Harish-Chandra Research Institute at Chhatnag Road, Jhunsi, Prayagraj 211 019.
- 3. Deadline for receipt of tender **11.00 a.m.** on or before **23.08.2021.** Late submitted tenders will not be considered.
- 4. The tender will be opened at the above office at **11.30 p.m.** on **23.08.2021** and your authorized representatives can be present at the time when the tenders are so opened.
- 5. The party should have to submit the following documents, without that they will not be considered in tender.
 - a. The bidder should be registered under GST. They have to submit a proof of Registration with their bid.
 - b. Experience of at least one work related to civil maintenance worth not less than Rs. 1.0 lakh in Govt./Semi Govt. organization in last 3 year ending 22.08.2021.
- 6. A deposit at call Receipt or Demand Draft/FDR of scheduled Bank guaranteed by the Reserve Bank of India for the **Earnest Money Deposit of Rs. 6,000/-** in favour of Registrar, HRI, Prayagraj is to be enclosed with the Tender Document at the time of submission. In reference of letter no. F.9/4/2020-PPD Govt. of India, Ministry of Finance, Micro and small Enterprises (MSEs) and the firms registered with HRI are exempted from submission of Bid Security. However, if they withdraw or modify their bids during period of validity of tender etc. then they will be suspended for participating in any tender of HRI for minimum two years or decided by competent authority from the date of opening of concerned tender. The tender of parties submitted without EMD or supporting document for exemption criteria of EMD shall be rejected.
- 7. The period of contract is for two years. However, initially it will be awarded for one year & based on satisfactory performance it will be renewed for another year.
- 8. The schedule of quantity is indicative are tentative. Actual quantity will vary based on the actual requirement.
- 9. The garbage will be shifted three times in a week or as per requirement from campus.
- 10. **Payment terms:** Payment will be made on monthly basis as per actual measurement duly certified by Engineer, HRI.
- 11. Evaluation criteria of lowest bidder The bidder will be finalized based on their total lowest quoted amount both first & second year AMC.
- 12. From the bill amount 5% security money will be deducted. The security money will be released only after completion of AMC & all dues clearance from concerned HRI section.
- 13. Don't detach any paper from the tender document and put the signature at all the papers of the tender document.
- 14. Institute will not to be bound to accept conditionals tenders.
- 15. The garbage should not be disposed within 0.5 km from the periphery of the campus. There will be whole responsibility of the contractor related to disposal of garbage.
- 16. The documents containing bids shall be free from cutting and erasures. However, alterations, if any, in the tender should be attested properly by the bidder, failing which the tender is liable to be rejected.

- 17. Procedure for dealing with ambiguities in rates: That if on check there are differences between the rates given by the contractor in words and in figures or in amount worked out by him, the following procedure shall be followed:
 - (a) When there is a difference between the rates in figures and in words, the rates which correspond to the amounts worked out by the contractor shall be taken as correct.
 - (b) When the amount of an item is not worked out by the contractor, or if it does not correspond with the rates written either in figures or in words, then the rate quoted by the contractor in words shall be taken as correct.
 - (c) When the rate quoted by the contractor in figures and in words tallies, but the amount is not worked out correctly, the rates quoted by the contractor shall be taken as correct and not the amount.
- 18. The tenders submitted by fax/email will not be considered.
- 19. Party is requested to submit the required details on separate sheet alongwith tender:
