### **INVITES APPLICATIONS FOR THE POST OF DIRECTOR, HARISH-CHANDRA RESEARCH INSTITUTE**

The Harish-Chandra Research Institute (HRI) is looking for an eminent scientist/mathematician/engineer of international repute for appointment to the post of the Director of the institute.

HRI was established in 1975 as the Mehta Research Institute, Allahabad. The institute has functioned as a Grant-in-Aid institution under the administrative control of the Department of Atomic Energy, Government of India from 1992. The institute was renamed after the renowned mathematician Professor Harish-Chandra in 2000.

The mission of the institute is to conduct research and to train students and advanced scholars in the areas of the Natural Sciences and Mathematical Sciences, with particular emphasis on Theoretical Physics and Mathematics. Further, to keep abreast of the developments and to establish and maintain contact with researchers worldwide in these areas through collaborations, conferences, mutual visits, and other means.

HRI is a Constituent Institution (CI) of the Homi Bhabha National Institute (HBNI), a deemed university.

#### **Scale of Pay of the Post :**

The scale of pay of the post of the Director, HRI is in Pay Level 15 of the VII CPC Pay Matrix plus allowances as per the rules of the Government of India.

#### **Other Benefits :**

Residential accommodation on the campus of the institute and health care benefits as per the rules of the institute shall be provided.

#### **Tenure of Post :**

The Director, HRI shall hold office for five years from the date of appointment or until the age of 60 years, whichever is earlier. The tenure may be extended in accordance with the provisions of the Bye-laws of the institute.

### **Nature of Duties :**

The Director, HRI is the Academic and the Administrative Head of the Institute and has the overall responsibility for carrying out the functions and responsibilities assigned to the institute by the Government of India or the Governing Council of the institute. The Director shall carry on the work of the institute under the control of the Governing Council of institute in accordance with the Bye-laws of the institute and the Rules/Sub-rules for the administration and the management of the institute.

A detailed description of the duties of the Director of the institute, as presently prescribed, is given in the Bye-laws of the institute, available on its website [www.hri.res.in](http://www.hri.res.in).

The service conditions for the post of the Director of the institute shall be as per the Bye-laws of the institute, as amended from time to time, and in accordance with other conditions as may be fixed by the Governing Council of the institute following the norms provided by the Department of Atomic Energy.

**Eligibility Criteria :** Indian citizens meeting the following criteria on age, educational qualifications and essential experience may apply for the post.

**Age :** Candidates shall not be less than 50 years of age and shall not be more than 57 years of age as on **01.02.2024**, which is the date on which the vacancy for the post is expected to arise.

**Educational Qualifications :** The candidate should have a Ph.D. degree in a subject relevant to the research areas of institute and other related areas, with a first class or equivalent at the preceding degree. The candidate should be an eminent scientist/mathematician/engineer with an excellent academic background and should have a track record of very high quality research publications in reputed peer reviewed journals. Proven leadership qualities and adequate experience in the management of scientific/research groups are necessary.

The research areas of the institute are listed on its website [www.hri.res.in](http://www.hri.res.in) in summary form on the main page and in greater detail under Mathematics >> Research and Physics >> Research.

### **Essential Experience :**

1. The candidate should have experience either in the analogous grade (Pay Level 15 of the VII CPC Pay Matrix) or at least five years in the grade one below, that is, Professor or SO (H) (Pay Level 14 of the VII CPC Pay Matrix).
2. The candidate should have rich experience in project implementation with optimum utilization of available resources.

### **Desirable Qualifications and Experience :**

1. Candidates who are fellow of the premier science academies of India (such as the Indian National Academy of Sciences, New Delhi, the National Academy of Sciences, Bengaluru and the National Academy of Sciences, India at Prayagraj) or having academic recognition from reputed institutes/universities shall be preferred.
2. Experience in national or international scientific collaborations shall be an added advantage.
3. Candidates are expected to be familiar with administrative and financial matters.

**Selection Procedure** : Appointment to the post shall be made by the Governing Council of HRI with the approval of the Appointments Committee of the Cabinet (ACC) and on the recommendation of the Search-cum-Selection Committee constituted by the Department of Atomic Energy for the purpose of selecting the Director, HRI. This Search-cum-Selection Committee will consider the applications received in response to this advertisement as well as nominations received from eminent persons.

**Application Procedure** : Applications/nominations in hard-copy and in **the prescribed format**, available with this advertisement, along with the required attachments and self-attested copies of certificates/testimonials in support of age, qualifications and experience should be delivered to the following address.

Persons employed in Government Departments or Autonomous Organizations under them must send their applications through proper channel.

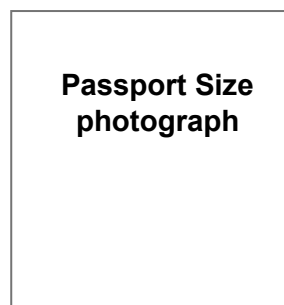
